CONDITIONS OF TRANSFER							
1.	That the new owner should keep in force an insurance policy against any claim in respect of the above Rottweiler. Insurance should cover Veterinary Fees and Third Party Liability. Should you not take out insurance cover, then you agree to pay for any treatment/claim in relation to your adopted dog. Rottweilers In Need cannot be held responsible for any costs once the dog is transferred into your care.						
2.	That should they, for any reason, be unable to keep the Rottweiler, it will be returned to Rottweilers In Need.						

- That billouid uney, for any reason, or unable to heep the restriction, it will be retained to receive loss of in receiver.
 That they will notify the Police and Rottweilers In Need within 24 hours, should the Rottweiler become lost or missing.
- 4. That they will not, or allow anyone else, to use this Rottweiler for experimental purposes, nor shall it be kept chained or tied.
- 5. That an authorised officer of Rottweilers In Need be allowed to visit your premises from time to time, on reasonable prior notice, and reclaim the Rottweiler, should they not be satisfied as to its welfare.
- 6. That the owner shall comply with any laws and regulation as laid down by the Government in respect `of Rottweilers.
- 7. That this Rottweiler will not be used for breeding, any financial gain or any purpose that could be deemed detrimental to the breed and:
 - 7a If a bitch, she will be spayed within 6 months from the above date and the obligatory spaying certificate be completed and returned to Rottweilers In Need.
 - 7b If a dog, he will at no time be used at stud.
 - 7c At no time shall two entire males be kept
- 8. That Rottweilers In Need will be notified of any change of address or telephone while the dogs is in your ownership.
